## Fees for Antenatal Care as a patient delivering in a Public Hospital

Thank you for choosing your antenatal care in our private specialist rooms. This document outlines the fees that will apply to your antenatal care.

## **Charity Fee**

Since 2016, Dr O'Rourke, his family and patients have generously donated more than \$1.6 million to the Muder Ignacia Hospital in Soe, West Timor.

To assist in raising much needed funds for the Muder Ignacia Hospital, Dr O'Rourke will forgo the income from our full standard Planning and Management fee by way of you making a direct donation to the John James Foundation - our charity partner to raise funds for the Muder Ignacia Hospital.

Therefore, as an antenatal patient delivering in a public hospital, we require a **tax-deductible CharityFee payment of \$2,000** - the Planning and Management fee (16591) will be bulk-billed on your behalf.

The Charity Fee facilitates personalised pregnancy care - including consideration of delivery preferences, managing pathology, scans, wellbeing check at 28 weeks and consulting with our clinical midwife each time you see Dr O'Rourke. Essentially, personalised continuity of care throughout your pregnancy and prompt quality management of any complications of pregnancy that may occur.

You will receive instructions on how to make the Charity Fee donation from 18 weeks. For our accounting purposes, <u>a donation receipt from the John James Foundation in the amount of \$2,000 is required by 34 weeks.</u>

## **General Antenatal Care fees**

These fees are a reflection of the professional services provided to you by Dr David O'Rourke, the costs of running a specialist practice and the high cost of Medical Indemnity Insurance.

Your first visit will be the Initial consultation (16401) and you can expect to have around 7 additional antenatal visits with payment due at each visit. Consultations with our midwife are complimentary.
